Privacy Policy

1. Introduction

2. Information We Collect

We may collect the following categories of information from you:

A. Personal Information

- Full name, date of birth, nationality

B. Program-related Information

- Attendance records, academic or performance data
- Photographs, videos, and feedback forms
- Payment and billing information (only necessary details, not card data)

C. Technical Information

 Website usage data (cookies, IP address, device details) when you access UMA's website or digital platforms.

3. Purpose of Data Collection

Your personal information is collected and used strictly for the following purposes:

- To process your registration and participation in the United Motorsports Academy Program.
- To communicate program-related updates, schedules, and certifications.
- To manage attendance, learning outcomes, and student records.
- To comply with legal or regulatory obligations.
- To improve our training programs and services.
- To use limited content (photos, videos, testimonials) for educational or promotional purposes, as per your consent.

4. Legal Basis for Processing

We process your personal data based on:

- Your consent, provided during registration or participation.
- **Performance of a contract**, i.e., delivering the UMA Programs.
- **Legal obligations**, such as recordkeeping or compliance requirements.
- Legitimate interest, such as maintaining program integrity and security.

5. Data Sharing and Disclosure

UMA does **not sell or rent** your personal data.

Your information may be shared only with:

- Official program partners (e.g. instructors, or affiliated training teams).
- Authorized service providers handling communication, certification, or event logistics.
- Government or regulatory authorities if required by law.

All such entities are bound by confidentiality and data protection obligations.

6. Data Storage and Retention

- Personal data will be stored securely on UMA's systems and servers.
- Data is retained **only as long as necessary** for program operation, certification verification, or legal compliance.
- Once data is no longer needed, it will be securely deleted or anonymized.

7. Your Rights

Under the **Digital Personal Data Protection Act, 2023**, you have the following rights:

- Right to Access Request a copy of your personal data.
- **Right to Correction** Request correction of inaccurate or outdated data.
- Right to Erasure Request deletion of your personal data (subject to legal limits).
- **Right to Consent Withdrawal** Withdraw consent for processing, after which participation-related services may be affected.
- **Right to Grievance Redressal** File a complaint regarding misuse or unauthorized access of your data.

UMA implements reasonable **technical and organizational safeguards** to protect your data from unauthorized access, alteration, disclosure, or destruction.

These include encrypted databases, restricted access controls, and secure data transmission protocols.
